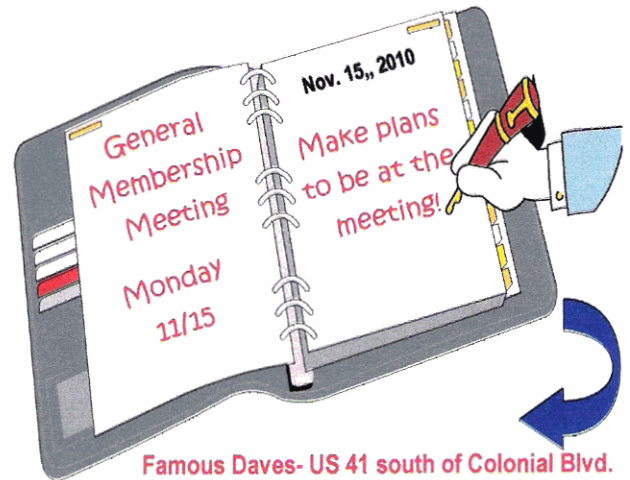

Dot's Crispy Oat Cookies

- | | |
|---------------------------|-------------------|
| 1 cup soft butter | 1 cup white sugar |
| 1 egg | 1 cup brown sugar |
| 3 1/2 cups flour | 1 tsp. vanilla |
| 1/2 tsp. salt | 1 tsp. soda |
| 1 cup crushed corn flakes | 1 cup oatmeal |
| 1 cup vegetable oil | 1/2 cup coconut |
| 1/2 cup chopped nuts | |



Cream butter, gradually add sugars, beating well at med. speed. Add egg and beat well. Add oil & vanilla, mixing well. Combine flour, soda and salt. Add to creamed mixture, mixing well. Stir in oats and remaining ingredients. Shape dough into 1 inch balls. Dough will be very thick. Place on ungreased cookie sheet and flatten with fork. Bake at 325 for 15 min. Cool on rack. Yield 10 doz.
